1. INTRODUCTION

- 1.1. Surf Coast Mountain Bike Club (SCMTB) is committed to ensuring that children and young people who participate in its activities have a safe and happy experience. SCMTB supports and respects children, young people, staff, volunteers and participants.
- 1.2. The aim of SCMTB's Child Safe Policy (the Policy) is to protect the safety of children in our care and prevent abuse from occurring, and in the event that allegations are raised in relation to child abuse, to ensure that the allegations are properly addressed. All complaints will be treated seriously and fully investigated and handled with maximum confidentiality and discretion.

2. POLICY STATEMENT

- 2.1 SCMTB is committed to providing the highest level of membership service. This includes protecting members' privacy, promoting positive behaviours and attitudes, protecting the health safety and wellbeing of members, particularly children and delivering SCMTB's activities while acting in the best interests of children in the sport.
- 2.2 Specifically, SCMTB considers that the health, safety and well-being of children takes priority over all other competing considerations. SCMTB considers that this is necessary to ensure the health, safety and welfare of all members and protect the image and reputation of the sport, SCMTB and its members.
- 2.3 SCMTB has a zero tolerance approach to child abuse and is committed to promoting and protecting children from abuse and neglect to the greatest extent possible. All children have equal rights to protection from child abuse, regardless of their sex, religion, disability or sexual orientation etc.
- 2.4 Child protection is a shared responsibility between SCMTB, its office bearers, committee members, contractors, associates, parents/guardians, coaches, spectators, volunteers and general members of the SCMTB. Everyone that participates in SCMTB's activities is responsible for the care and protection of children, and reporting information about child abuse.
- 2.5 SCMTB supports the active participation of all children. It listens to their views, respects their views and involves them when making decisions, where appropriate, especially about matters that will directly affect them (including their safety).
- 2.6 SCMTB is also committed to the cultural safety of Aboriginal children, and those from culturally and/or linguistically diverse backgrounds, and to providing a safe environment for children living with a disability.

2.7 SCMTB promotes fairness and consideration for all staff, volunteers and participants. For further details please refer to the SCMTB (MTBA) Member Protection Policy.

3. SCOPE

- 3.1.1. This Policy applies to committee members, participants, parents, spectators, contractors, officials, coaches, judges, volunteers and staff throughout all SCMTB events and activities.
- 3.1.2. This Policy will continue to apply retrospectively to a person or Member following the cessation of their association or employment with SCMTB
- 3.1.3. SCMTB is supported by its governing body, Mountain Bike Australia (MTBA) MTBA has in place its own suite of child safe policies that align with the SCMTB policy.

4. DEFINITIONS

- 4.1. **Child** means a person involved in the activities of SCMTB (including athletes) and under the age of 18 years unless otherwise stated under the law applicable to the child.
- 4.2. **Child protection** means any responsibility, measure or activity undertaken to safeguard children from harm.
- 4.3. **Sexual offence** means a criminal offence involving sexual activity or actions of indecency or any act which exposes a child to, or involves a child in, sexual activity or matters beyond his or her understanding or contrary to accepted community standards. It also includes child grooming, which includes actions deliberately undertaken with the aim of befriending and establishing an emotional connection with a child (or the child's carer, family or supervisor) to lower the child's inhibitions and prepare them for engagement in a sexual offence.
- 4.4. **Mandatory reporter** means a person who is legally required to make a report to the Department of Human Services or the Police if they form a belief on reasonable grounds that a child is in need of protection. It includes teachers, principals, registered psychologists, nurses, doctors and midwives.

5. RECOGNISING AND REPORTING CHILD ABUSE

- 5.1. A person may, in the course of participating in the sport or other activities of SCMTB or carrying out their work, form a belief on reasonable grounds that a child is in need of protection from child abuse.

5.2. If a person is concerned about an immediate risk to a child's safety, the person must phone "000" as soon as practicable.

5.3. **Child abuse** can be divided into four categories:

5.3.1. **Physical abuse:** occurs when a child has suffered, or is likely to suffer, significant harm as a result of a physical injury, such as a non-accidental physical injury.

5.3.2. **Sexual abuse:** occurs when a child has suffered, or is likely to suffer, significant harm as a result of sexual abuse, such as when a child is exploited, or used by another for his or her sexual gratification or sexual arousal, or for that of others.

5.3.3. **Emotional and psychological abuse:** occurs when a child has suffered, or is likely to suffer, emotional or psychological harm of such a kind that the child's emotional or intellectual development is or is likely to be significantly damaged; and

5.3.4. **Neglect:** occurs when a child's physical development or health has been, or is likely to be significantly damaged. It refers to an omission, such as depriving a child of food, clothing, warmth, hygiene, intellectual stimulation, supervision and safety, attachment to and affection from adults, or medical care.

5.4. Child abuse includes any actions that results in actual or potential harm to a child, in circumstances where the child's parents have not protected, or are unlikely to protect, the child.

5.5. **Mandatory Reporters**

5.5.1. Select classes of people in the community (including teachers, nurses and doctors) are required by law to report to the Child Protection Unit of the Department of Health and Human Services (DHHS) where they have formed a belief, on reasonable grounds, that a child is in need of protection because they have suffered (or are likely to suffer) significant harm due to physical or sexual abuse.

5.5.2. This report must be made as soon as practicable, and after each occasion where he or she becomes aware of a further reasonable grounds for the belief.

5.6. **Reasonable grounds for belief**

5.6.1. A reasonable belief is formed if a reasonable person believes that:

5.6.1.1. the child is in need of protection;

5.6.1.2. the child has suffered or is likely to suffer significant harm as a result of physical or sexual injury; and

5.6.1.3. the child's parents are unable or unwilling to protect the child.

- 5.6.2. To form a reasonable belief, you should consider and objectively assess all the relevant facts, such as the source of the allegation and how it was communicated, the nature of and details of the allegation, and whether there is any other related matters known regarding the alleged perpetrator.
- 5.6.3. A 'reasonable belief' or a 'belief on reasonable grounds' is not the same as having proof, but is more than mere rumour or speculation.
- 5.6.4. You will have reasonable grounds to notify if:
- 5.6.4.1. a child states that they have been physically or sexually abused;
 - 5.6.4.2. a child states that they know someone who has been physically or sexually abused (sometimes the child may be talking about themselves);
 - 5.6.4.3. someone who knows a child states that the child has been physically or sexually abused;
 - 5.6.4.4. professional observations of the child's behaviour or development leads a professional to form a belief that the child has been physically or sexually abused or is likely to be abused; or
 - 5.6.4.5. signs of abuse lead to a belief that the child has been physically or sexually abused.

5.7. Voluntary Reporters

- 5.7.1. In addition to the mandatory reporting obligations above, any person who believes on reasonable grounds that a child is in need of protection from any form of child abuse, *may* disclose that information to the Police or DHHS.

5.8. Reporting Child Sexual Abuse

- 5.8.1. If a person receives information that leads them to form a reasonable belief that a sexual offence has been committed in Victoria against a child (under the age of 16 years) by another person (of or over the age of 18 years), the person has a legal obligation to disclose that information to the Police as soon as it is practicable. Individuals who fail to comply with this obligation under the Crimes Act 1958 (Vic) may be subject to a penalty of 3 years imprisonment.

5.9. Approach to Reports of Abuse

- 5.9.1. SCMTB supports and encourages a person to make a report to the Police or DHHS if they form a belief on reasonable grounds that a child is in need of protection, or they are concerned about the safety, health or wellbeing of a child.
- 5.9.2. Any person that makes a report in good faith in accordance with their reporting obligations (whether mandatory or discretionary) will be supported by SCMTB and will not be penalised by SCMTB for making the report.

- 5.9.3. If a person is uncertain as to whether they should make a report to an external authority in relation to the safety of a child, they may speak to the SCMTB President and/ or the SCMTB Child Safety Officer for guidance and information. If in doubt, ask for assistance.
- 5.9.4. If an allegation is made against a member of the club, SCMTB will follow the reporting process outlined in SCMTB Child Safe Reporting Process and take all steps to ensure that the safety of the child is paramount.
- 5.9.5. SCMTB will investigate allegations of inappropriate conduct against a child in accordance with procedural fairness and will handle the allegations in a confidential manner to the greatest extent possible.
- 5.9.6. SCMTB will cooperate with the directions of the Police and/or DHHS in relation to any investigation conducted by these authorities.
- 5.9.7. SCMTB will keep a register of any allegations regarding inappropriate conduct.

6. ROLES AND RESPONSIBILITIES OF PERSONNEL PROTECTING CHILDREN

- 6.1. Personnel involved in protecting children include the Child Safety Officer, Office bearers, the committee and volunteers within the Organisation. Those people have responsibilities in relation to protection of children and are expected to:
 - 6.1.1. understand the rights of children, as appropriate to their role;
 - 6.1.2. respect the cultural and religious practices of families who access SCMTB 's services, programs or events;
 - 6.1.3. understand and appropriately respond to the needs of children with developmental delays or disabilities;
 - 6.1.4. appropriately act on any concerns raised by children;
 - 6.1.5. understand the definitions, indicators and impact of child abuse:
 - 6.1.6. know and follow regulations in relation to the care of children;.
 - 6.1.7. co-operate with police and/or other formal investigations to the best of their ability; and
 - 6.1.8. not harm or exploit children who access SCMTB's services and activities .

7. CHILD SAFE AND CHILD FRIENDLY GUIDELINES TO PREVENT AND MANAGE RISKS OF CHILD ABUSE

7.1. Change Rooms

7.1.1. Adult officials, regardless of gender, should only enter change rooms where under age participants have gathered if accompanied by another adult. Prior to entering change rooms, officials should notify the people in the change room of their intended entrance. For the avoidance of doubt this requirement does not apply to parents/legal guardians when in a room with their child.

7.2. Hotel rooms and other accommodation

7.2.1. No official should be alone in the room of an under age athlete without the presence of another adult. The doors should always be open. Should it be necessary for an official to be alone in the room of an athlete, the Team Manager or other responsible official must be informed. For the avoidance of doubt this requirement does not apply to parents/legal guardians when in a room with their child.

7.3. Travel - General

7.3.1. All team members over 18 years of age retain an overriding responsibility for the welfare of all under age athletes they accompany during team travel activities. They have a 'duty of care' for athletes and they must meet that duty and avoid unaccompanied and unobserved activities with persons less than 18 years of age wherever possible. For the avoidance of doubt this requirement does not apply to parents/legal guardians when in a room with their child.

7.4. Sexual Relationships while on tour.

7.4.1. During all team travel activities officials must not, under any circumstances engage in conduct of a sexual nature with an under age athlete. Improper conduct of a sexual nature by an official towards an under age athlete includes any form of child sexual abuse as defined in this policy as well as but not limited to the following:

- 7.4.1.1. inappropriate conversations of a sexual nature;
- 7.4.1.2. obscene language of a sexual nature;
- 7.4.1.3. suggestive remarks or actions;
- 7.4.1.4. jokes of a sexual nature;
- 7.4.1.5. obscene gestures;
- 7.4.1.6. unwarranted and inappropriate touching;
- 7.4.1.7. sexual exhibitionism;
- 7.4.1.8. use of any device to show/watch offensive material; and
- 7.4.1.9. any other action that could lead to an under age athlete being physically, emotionally or psychologically harmed.

7.5. Adults under investigation

7.5.1. Adults under investigation in relation to a matter involving child abuse, or any matter which has the potential to jeopardise their Working With Children Check (WWCC) status may be prohibited, by the SCMTB committee, from participating in SCMTB activities.

7.6. Coach Assistance

7.6.1. All coaches must ensure that all physical contact with under age athletes which occurs when coaching is appropriate for the situation and necessary for the athlete's safety. It is strongly recommended that:

7.6.1.1. coaches ensure that there are other adults present whenever coaching;

7.6.1.2. coaches take care to explain the procedure to the child prior to beginning any physical contact; and

7.6.1.3. coaches obtain consent from the athlete prior to beginning any physical contact.

8. ENGAGING NEW PERSONNEL

8.1. The minimum standard for background checks of employees and volunteers of SCMTB and its members is the law as it applies in Victoria.

8.2. SCMTB undertakes a comprehensive recruitment and screening process for all staff and volunteers which aims to:

8.2.1. Promote and protect the safety of all children who participate in the activities of SCMTB

8.2.2. Identify and recruit the safest and most suitable candidates who share SCMTB's values and commitment to protect children; and

8.2.3. Prevent a person from working or volunteering at SCMTB if they pose an unacceptable risk to children.

8.3. SCMTB requires staff and volunteers to pass the recruitment and screening process prior to commencing their engagement with SCMTB

8.4. As part of the screening and recruitment process, an applicant must provide appropriate evidence (e.g. WWCC or other state equivalent and/or Police check) to show that they are suitable to work with children and young people in a recreational setting.

8.4.1. All SCMTB committee members require a WWCC

- 8.4.2. Volunteers, staff, relevant contractors who may have unsupervised access to children and anyone else who SCMTB staff feel requires a WWCC due to the nature of the work that they are undertaking for SCMTB
- 8.5. The type of evidence that an applicant is required to provide to SCMTB will vary depending on the type of position that they are applying for. However, an applicant will not be offered a position until they provide the required evidence to SCMTB
- 8.6. SCMTB will exercise discretion and may require applicants to provide a Police check in accordance with the law and as appropriate, before they commence their engagement and during their time with SCMTB in regular intervals.
- 8.7. Once engaged, SCMTB will provide staff and volunteers with access to this policy and other related documents and staff and volunteers must review and acknowledge their understanding of this policy and other related documents .

9. RISK MANAGEMENT APPROACH

- 9.1. Child safety is a part of SCMTB 's overall risk management approach.

10. POLICY BREACHES

- 10.1. It is a breach of this policy for any person or organisation to which this policy applies, to have been found to have done anything contrary to this policy. Any person who may breach this policy is subject to the SCMTB (MTBA) Member Protection Policy

11. POLICY PROMOTION

- 11.1. This policy will be made available to all members via a link from the SCMTB website or will be emailed to them
- 11.2. This policy will be communicated to all Committee members via email, then discussed and if agreed upon will be voted on by committee members

12. REVIEW PROCESS

- 12.1. This policy will be reviewed by the SCMTB committee on a biennial basis.
